

Rising Queens Foundation Privacy Policy

Effective Date: August 2025

Rising Queens Foundation (“we,” “our,” “us”) values your privacy and is committed to protecting your personal information. This Privacy Policy explains how we collect, use, store, and safeguard the information you provide when engaging with our programs, donations, volunteering, and website.

1. Information We Collect

We may collect the following types of information:

- **Personal Information:** Name, email address, mailing address, phone number, and date of birth (for program participants).
- **Donor Information:** Name, contact details, billing address, and payment details when processing donations.
- **Program Information:** Registration details for workshops, mentorships, or events, including parental/guardian contact details for minors.
- **Website Information:** IP address, browser type, and usage data collected through cookies and analytics tools.
- **Volunteers & Partners:** Background information necessary for participation in volunteer or partnership opportunities.

2. How We Use Your Information

We use your information to:

- Register participants for programs, events, and workshops.
- Communicate with donors, volunteers, and participants about updates, opportunities, and events.
- Process and acknowledge donations, including sending tax receipts.
- Ensure transparency and accountability in donor contributions.
- Improve our programs, website, and outreach.
- Comply with legal, financial, and grant reporting requirements.

3. Donor Privacy

- We respect and protect the confidentiality of our donors.
Donor names, contact information, and contributions are never sold, traded, or shared with third parties for marketing purposes.
- Donors may choose to remain anonymous when making a contribution.
- Donation records are used only for reporting, acknowledgment, and compliance purposes.

4. Sharing Your Information

We **do not sell or rent** your personal information. We may share information only in the following cases:

- **Service Providers:** With trusted third-party vendors who help us process donations, manage communications, or support events.
- **Legal Requirements:** When required by law or to protect the safety of our participants, donors, staff, and organization.
- **With Consent:** When you have given us permission to share your information for a specific purpose.

5. Protecting Your Information

We implement appropriate administrative, technical, and physical safeguards to protect your personal information from unauthorized access, use, or disclosure. However, no method of transmission or storage is 100% secure.

6. Children's Privacy & Parental Consent

- Rising Queens Foundation works with teenage girls and requires **parental or guardian consent** for participants under 18.
- We collect only the necessary personal information to support program participation.
- We do not knowingly collect personal information from children under 13 without verifiable parental consent.
- Parents and guardians have the right to review, update, or request deletion of their child's personal information at any time.

7. Your Rights

Depending on your location, you may have the right to:

- Access, update, or correct your personal information.
- Request that we delete your information.
- Opt out of receiving communications from us.
- Request anonymity in donations.
